## No. 919.

**AN ACT to Create an Airport Commission for the City and County of Greenville and Define its Powers and Duties and to Authorize the City of Greenville to Make Certain Donations to Said Commission.**

**Section 1. Greenville Airport Commission—Appointment.**—Be it enacted by the General Assembly of the State of South Carolina: There is hereby created a Commission for the City and County of Greenville, to be known as Greenville Airport Commission. This Commission shall consist of five members to be selected as follows: Two by the City Council of the City of Greenville; two by the Greenville County Delegation in the General Assembly and one to be selected by a majority vote of the four selected as hereinabove provided.

**§ 2. Terms.**—That the term of office of the members of this Commission shall be as follows: The two appointed by the Greenville County Delegation shall serve for a period of two years; the two appointed by the City Council shall serve for a period of four years, and the one selected by the Commission shall serve for a period of six years, and at the expiration of the terms of office of the Commission as hereinabove selected, the term of office of each Commissioner shall be for a period of two years and until his successor is appointed and qualifies.

**§ 3. Chairman.**—The Commission herein appointed shall select one of its number as Chairman.

**§ 4. Powers.**—The Commission herein created is hereby vested with the power to receive any gifts or donations from any source, and also to hold and enjoy property, both real and personal, in the County of Greenville, as granted to individuals under the laws of this State, for the purpose of establishing and maintaining aeroplane landing fields and county parks in the County of Greenville; and to make such rules and regulations as may be necessary in the conduct and operation of said aeroplane landing fields and county parks.

**§ 5. City of Greenville may Aid.**—The City of Greenville is hereby empowered and authorized to appropriate and donate to said Commission such sums of money as it may deem expedient and necessary for the purposes aforesaid.

**§ 6. Abandonment of Airport.—**That in case the property acquired by the Commission as aforesaid shall cease to be used for the purposes herein provided, then all of the said property, both real and personal, may be by the Commission sold and converted into cash and said proceeds shall be divided among the City of Greenville, the County of Greenville, the Park and Tree Commission of the City of Greenville, and the American Legion organization of the County of Greenville, in equal proportion, and to that end the said Commission is hereby authorized by such officers as it may designate to make, execute and deliver deed or deeds of conveyance to any and all of said property.

**§ 7.** All Acts or parts of Acts inconsistent herewith are hereby repealed.

**§ 8.** This Act shall take effect immediately upon its approval by the Governor.

**AN ACT to Validate an Election Held on the 14th Day of October, 1925, in School District No. 27 of Greenwood County, the State of South Carolina, Commonly Called Troy School District No. 27, of Greenwood County, the State of South Carolina, on the Issuance of Fifteen Thousand (\$15,000.00) Dollars of Bonds by Said School District for the Purpose of Erection of School Building in Said Building; and to Validate the Issuance and Sale of Said Bonds, or so much Thereof as Can be Issued Within the Constitutional Eight Per Cent. Limitation.**

**Section 1.** Be it enacted by the General Assembly of the State of South Carolina: That the election held on the 14th day of October, 1925, in School District No. 27, of Greenwood County, the State of South Carolina, commonly called Troy School District No. 27, of Greenwood County, the State of South Carolina, on the issuance of Fifteen Thousand (\$15,000.00) Dollars of bonds of said School District, the proceeds to be used for the erection of school building therein, be, and the same is hereby, validated and declared to be legal in all respects, and any bond or bonds, to an amount not
