**No. 1417****An Act To Classify Tax Levies For The Operation And Maintenance Of The Greenville County Library And To Prohibit Exemptions From Taxation.**

Be it enacted by the General Assembly of the State of South Carolina:

**SECTION 1. Tax to be for Educational Purposes.**—All tax levies for the operation and maintenance of Greenville County Library shall be deemed to be for educational purposes and no exemptions therefrom shall be granted to any new manufacturing industry or additions to any industry.

**SECTION 2. Time effective.**—This act shall take effect upon approval by the Governor.

Approved the 20th day of June, 1974.

(R1459, H3384)**No. 1418****An Act To Amend Section 2 Of Act 919 Of 1928 Relating To The Terms Of Members Of The Greenville County Airport Commission, So As To Change The Terms To Three Years And To Provide For Staggered Terms.**

Be it enacted by the General Assembly of the State of South Carolina:

**SECTION 1. Terms.**—Section 2 of Act 919 of 1928 is amended by striking all after the word "be" in line two and inserting "for three years and until their successors are elected and qualify." The section, when amended, shall read:

"Section 2. That the term of office of the members of this Commission shall be for three years and until their successors are elected and qualify."

**SECTION 2. Terms further.**—Notwithstanding the provisions of Section 1, of those successors to the members currently serving, one each shall be appointed by the City Council of the City of Greenville and the County Council of Greenville County for an initial term of one year, and one each shall be likewise appointed for an initial term of two years.

**SECTION 3. Time effective.**—This act shall take effect upon approval by the Governor.

**An Act To Validate An Annexation Of Territory In Greenville County To Piedmont Sewer, Light And Fire District Of Anderson And Greenville Counties For Fire Protection Purposes Only; To Empower The Piedmont Sewer, Light And Fire Commission To Levy A Tax On Property Within Such Annexed Territory For Fire Protection Purposes; To Create Within Such Annexed Territory Of Piedmont Sewer, Light And Fire District Of Anderson And Greenville Counties Industrial Subdistricts Nos. 1 And 2; To Prohibit The Piedmont Sewer, Light And Fire Commission From Levying Any Tax Upon The Property Within Such Subdistricts For The Purpose Of Paying Or Servicing The Bonded Indebtedness Of The District; And To Provide A Limitation Upon Any Tax To Be Levied By Such Commission Upon The Property Within Such Subdistricts For Operational Purposes.**

Whereas, by Act 389 of 1955, as amended by Act 449 of 1963 and Act 1839 of 1972, the General Assembly validated, ratified, approved, and confirmed the establishment of a special purpose district in Anderson and Greenville Counties now known as Piedmont Sewer, Light and Fire District of Anderson and Greenville Counties; and pursuant to the power and authority conferred by the aforementioned Acts, the Piedmont Sewer, Light and Fire Commission has and is now operating within the boundaries of said District (as the same were established by the aforementioned Acts) a public sewer system, a street lighting system, and a public fire department and fire control system; and

Whereas, on or about April 30, 1974, the Piedmont Sewer, Light and Fire Commission, pursuant to the petition of a majority of the freeholders in the prospective area, extended the boundaries of said District by annexing to said District, for fire protection purposes only, substantial additional contiguous territory entirely in Greenville County which embraces the areas designated herein as "Industrial
