

AN ORDINANCE

AN ORDINANCE TO AMEND CERTAIN SECTIONS OF ACT NO. 516 OF THE 1969 ACTS AND JOINT RESOLUTIONS AS PREVIOUSLY IMPLEMENTED AND AMENDED SO AS TO PROVIDE THAT THE GREENVILLE COUNTY REDEVELOPMENT AUTHORITY MAY FUNCTION WITHIN THE BOUNDARIES OF MUNICIPALITIES BY AGREEMENT; THAT THE TERMS OF INCUMBENT MEMBERS BE TERMINATED EFFECTIVE JULY 31, 1983, AND THE MEMBERSHIP OF THE AUTHORITY BE INCREASED TO NINE MEMBERS WHO SHALL EVENTUALLY SERVE STAGGERED THREE-YEAR TERMS: AND TO FURTHER PROVIDE THAT NO MEMBER SHALL SERVE MORE THAN TWO SUCCESSIVE TERMS, BUT INCUMBENT MEMBERS MAY BE REAPPOINTED.

BE IT ORDAINED BY GREENVILLE COUNTY COUNCIL:

SECTION 1. Subsections (b) (c) and (d) of Section 3 of Act No. 516 of the 1969 Acts and Joint Resolutions of the General Assembly of South Carolina, as implemented by Article VII of Chapter 2 of the Greenville County Code, and as amended by Ordinance No. 784 adopted by Greenville County Council on March 18, 1980, are further amended to read as follows:

"(b) The redevelopment authority of each municipality may function within the corporate limits of the respective municipality, and the county authority may function throughout the county outside the corporate limits of any municipality; provided, however, that the county redevelopment authority may function within the corporate limits of any municipality by agreement with such municipality.


"(c) The respective redevelopment authorities of each incorporated municipality shall consist of five commissioners appointed by the respective city or town councils. The Greenville County Redevelopment Authority shall consist of twelve electors appointed by the county council from single-member council districts as follows: the members residing in districts 17, 19, 20, and 21 for terms expiring September 30, 1983; the members residing in districts 18, 23, 24 and 28 for terms expiring September 30, 1984; and the members residing in Districts 22, 25, 26 and 27 for terms expiring September 30, 1985. Thereafter all terms will be for three years beginning October 1.

It is the intention hereof that all incumbent members will serve for the remainder of their current terms."

"(d) The term of office of the commissioners of each municipality authority shall be five years; provided, that of those first appointed one shall be appointed for one year, one for two years, one for three years, one for four years, and one for five years; provided, further that no member of the Greenville County Redevelopment Authority shall serve more than two successive three-year terms, but a member serving on the date hereof may be reappointed to serve one additional three-year term. Vacancies occurring by reason of death, disability, resignation, or other cause shall be filled by the County Council for the remainder of the unexpired term."

SECTION 2. This ordinance shall become effective on the date of its adoption.
