

A Message from the Chairman



Partnerships are the hallmark of conservation district history, and were the foundation upon which federal and state conservation district legislation was written. The Greenville County Soil and Water Conservation District has benefitted from federal, state and local partnerships. On the federal level, our staff works closely with the Natural Resources Conservation Service in helping landowners identify and implement appropriate conservation practices. On the state level, the District receives funding from the South Carolina Department of Natural Resources and benefits from SC DNR leadership. At the local level, the District is generously supported by Greenville County for which the District manages the education component of the County's state-issued storm water discharge permit.

The District also has partners who generously support our efforts to reach out to the community. Affiliate Member contributions allow the District to provide conservation education to Greenville County teachers and to engage students through our annual essay contest.

These partnerships and District staff have enabled the Greenville County Soil and Water Conservation District to continue its mission of putting soil and water conservation practices in place. As a result of programs undertaken by District staff, earlier this year the South Carolina Association of Conservation Districts recognized GCSWCD as the Outstanding Conservation District of 2011.

Another District program that has received note is the 'There is no Poop Fairy' campaign. The 'Poop Fairy' character can be seen on the District's web-site (accessible from Greenville County's web-site under Departments), at local pet stores and at the County's Animal Care Facility and reminds us that when not properly managed, pet waste hurts our rivers and streams. District staff is working on a new educational campaign that promises to be as educational and eye catching as the winged, slightly bald 'Poop Fairy'.

From the District Manager's Desk...

The Greenville District's most notable water quality project was in partnership with the Foothills Resource Conservation and Development Council, NRCS, DNR and the landowners. The project included upgrades to trout habitat on approximately a half mile of the South Saluda River. The District provided design expertise for the project. We have worked with this consortium for years, and this latest was the longest stretch of river rehabilitated thus far.



Our partnership with local water districts, neighboring conservation districts and with NRCS has allowed the 'Every Drop Counts' irrigation check program to continue for another year. In this program, a homeowner or producer in a supporting water district area is given a free audit of their irrigation system. The audit includes evaluation of soil, timer settings, and the efficiency of the system, resulting in helpful hints to conserve water. This conservation saves money and helps keep the water where it's wanted, instead of having it turn into runoff water.

In the third phase of projects with Long Branch Baptist Church, a shade sail was donated by the district to cover a bench near the new playground the church has opened to the community. The Long Branch projects have continued for four years and have gone from several blocks of dilapidated houses to a beautiful park setting with a trickling stream, multiple trees, an outdoor education center and now a fun-filled place for children to play. The Long Branch Baptist Church has turned a place of despair into a place of joy. We are proud to have partnered with such a great community.



The Greenville County Soil & Water Conservation District chose to be a primary sponsor of the Greenville Organic Foods Organization Urban Farm Tour this year. The farm tour draws around 500 people to visit little slices of farm life nestled in the city. One of our own Commissioners, David Gibble of Blueberry Hill farm, has been one of the farms to visit on the farm tour for two years. We appreciate the chance to further the education of people learning about growing their own food.

2011-2012 Education Program Report



Greenville County Soil & Water Conservation District's educational programs convey messages of natural resource conservation to a wide, multi-generational audience. Education Programs are made possible through the generosity of Affiliate Member donations.

- 584 County teachers participated in environmentally-themed workshops and training seminars through the SWCD. Workshops included activities from Project WILD, Leopold Education Project and Project WILD Aquatic
- 20 school classroom presentations, reaching 500 students, were delivered by Education staff
- 10 afterschool, summer camps and community group presentations on conservation were provided by Education staff, reaching 159 children
- 4 middle school students were awarded Science Fair prizes, recognizing projects on water quality and conservation
- With SWCD assistance, Brook Glenn Elementary School provided classrooms with indoor plants to improve air quality for 487 students
- The District provided a ComposTumbler and 14 worm bin composters to Greenbrier Elementary's garden club to set up a school lunch composting program, reaching 350 students throughout the year
- 64 local business owners and employees participated in water quality presentations and acted as partners in the District's storm water programs
- 3590 members of the public stopped by the SWCD's educational booths at Bark in the Park, Party for the Planet (Greenville Zoo), Greenville County Science Teachers' Association (Roper Mountain Science Center) and Earth Fest (Greenville Tech)
- 1,175 pet waste bag dispensers were given to dog owners at events throughout Greenville County
- 100 oil recycling pans were distributed through Greenville County Solid Waste Division's Recycling Centers
- 4 newsletter articles on water conservation were distributed to Homeowners' Associations
- Environmental Attitudes & Behavior survey of pet owners in association with Greenville County Recreation District was conducted
- The District sponsored Greenville Recreation District summer camp programs for children in need
- The annual essay contest had a record 455 entries this year
- District Education Program Manager, JC Ward, served as chair for the Environmental Education Association of South Carolina's conference in Greenville County

Natural Resource Conservation Service

This year has been another very productive one, as NRCS continued working with farmers and landowners in Greenville County, getting conservation on the ground, and helping people help the land. Along with providing technical assistance for erosion problems, drainage challenges and pond issues, farmers received cost-share funding from the Environmental Quality Incentive Program (EQIP) and the Wildlife Habitat Incentive Program (WHIP). These funds were used to install watering tanks, construct fencing, address heavy use areas, create water bars and position three high tunnels. (In case you are wondering what a high tunnel is: it is a polyethylene covered structure with no electrical, ventilation, or heating system and is at least 6 feet in height, modifying the climate to create more favorable growing conditions for vegetable and other specialty crops grown in the natural soil beneath it.) High tunnels cover several crop rows, are wide enough to allow crop growth to full maturity under the tunnel, and are tall enough to allow spraying, cultivation and harvest to occur with the tunnel intact. Natural resource benefits from using tunnel structures include: (1) improved plant quality, (2) improved soil quality, and (3) improved water quality through methods such as reduced nutrient and pesticide transport.

Included in your plan are your objectives and goals, aerial photographs, soils maps and soils descriptions and a schedule for applying conservation practices.
