Item (3) Public Hearings

a. Woodruff Road Congestion Relief Project

A public hearing was held for the purpose of receiving comments from the public regarding an ordinance to accept financial assistance from the South Carolina State Infrastructure Bank and provide a local match for the Woodruff Road Congestion Relief Project; and to authorize various agreements in furtherance of the project.

Item (4) Ordinance – Second Reading

a. Woodruff Road Congestion Relief Project

Action:

On behalf of the Committee, Vice-Chairman Tripp moved for approval at second reading an ordinance to accept financial assistance from the South Carolina State Infrastructure Bank and provide a local match for the Woodruff Road Congestion Relief Project; and to authorize various agreements in furtherance of the project.

Motion carried unanimously.

b. Road Improvement Funding

Action:

On behalf of the Committee, Vice-Chairman Tripp moved for approval at second reading an ordinance to authorize funding for road and bridge improvements for FY 2022, 2023, and 2024.

Action:

Vice-Chairman Tripp moved to amend the ordinance to reflect the changes outlined in the copy of the ordinance provided at each Council Member's seat and agreed upon during the Special Called Finance Committee meeting, held earlier in the day.

Vice-Chairman Tripp stated the \$30 million could be applied to roads and bridges over the proposed three-year time span or it could be used for the Woodruff Road Congestion Relief Project. If the monies were used for the Woodruff Road project, the County would save approximately \$15 million in interest payments.

Mr. Kernell stated the Woodruff Road Congestion Relief Project required \$30 million from Greenville County. Bonds could be issued and the County would repay the money over 20 years. The payment for the bonds would come from the Road Maintenance Fees, which were used to fund road maintenance. Mr. Kernell stated interest had to be paid when money was borrowed; the additional amount taken from the road maintenance fees would cover the interest. The proposed ordinance would shift cash to pay for the Woodruff Road Congestion Relief Project and the road maintenance fee would stay "whole." The interest on the bonds would be approximately \$10 - \$15 million.

Motion to amend carried unanimously.

Action:

On behalf of the Committee, Vice-Chairman Tripp moved approval at second reading an ordinance to authorize funding for road and bridge improvements for FY 2022, 2023, and 2024, as amended.

Motion carried unanimously.
