"On deeds, instruments, or writings whoreon any lands, tenements, or other realty, or any interest therein, shall be granted - - - "

Section 65-689, 1962 Code of Laws of South Carolina, imposes . a stamp tax on:

"A deed, instrument or writing whereby any lands, tenements or other realty sold shall be granted, assigned, transferred or otherwise conveyed - - -."

"Neither "tenements" nor "realty" includes a lease for a term of years, and our statute does not impose the tax on "lands - - - or any interest therein," as does the Florida statute. Words and Phrases V. 36 at p. 392, Realty, and V. 41 at p. 551, Tenement.
