KNOW ALL MEN BY THESE PRESENTS, That we, W.A. Simpson, J.P. Beam and V.L. Johnson, as Trustee of School District No. 4-C in the State and County aforesaid, and C.B. Tarrant of the State and County aforesaid, parties of the first part, hereinafter called the grantors, in consideration of the purchase by Greenville, Spartanburg & Anderson Railway Company from C.B. Tarrant of a tract of land containing 1.65 acres, and in consideration of the transfer of the said land to the Trustees of School District No. 4-C for the use of the said school; and in further consideration of the prospective advantages and benefits which may accrue to or be derived by said grantors, and their property, and the public, arising from the location, construction and operation of a line of railway through their country or neighborhood, do hereby grant, sell, release and convey unto the said Greenville, Spartanburg & Anderson Railway Company, a corporation organized and existing under and by virtue of the laws of the State of South Carolina, party of the second part, hereinafter called the grantee, its successors and assigns, all of the following rights, privileges and easements, to wit:

The right to peaceable entry, the right of way and easement, of surveying, constructing, building, operating, maintaining, improving and repairing a road line or railway to be run by electricity or other motive power, with one or more tracks, upon, along and over a belt, strip or right of way, one hundred feet in width, extending upon, over, through and across those two adjoining tracts of land situate in the County and State aforesaid, being the same tracts conveyed by the said C.B.
