Know all men by these Presents that I the said J.W.Norwood, as such Trustee under said deed of trust and in my individual right in consideration of the sum of Six hundred dollars to me in hand paid at and before the sealing of these presents, as such trustee under said deed of trust, and in my individual right by the said W.M.Jordan (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain sell and release unto the said W.M.Jordan all that piece, parcel and lot of land, situate, lying and being in the State and County aforesaid and City of Greenville, fronting on Norwood Avneue and being known as lot No.14 on Plat of W.A.Hudson, bearing date July Sth.1908, and having the following metes and bounds and courses and distances, to wit: Beginning at an iron pin at corner of said lot next to land, now or formerly of H.C.Markley and running thence N.34 W.62 feet along Norwood Avenue to Joint corner of said lot and lot No.15 on said plat; thence S.56 W.169 feet to an iron pin; thence S.34 E.62 feet to an iron pin on Merkley's line; thence N.56 E.169 feet to the beginning corner.
