This indenture made and entered into this the 3rd day of January 1912, by and between T.E. Green of the one part and Jefferson Powder Company a corporation under the laws of the State of Alabama, of the other part.

WITNESSETH:

That the said T.E. Green has hereby let and rented to the said Powder Company, and it has hereby hired and taken from him that certain piece, or parcel of land situate in the north-east corner of his tract of land near Peris Station; in the County and State aforesaid, and described as follows: beginning four hundred feet on the southern line between the said Green and the Edwards land, and running to the corner of the said Green's land a distance of four hundred feet; thence from said corner a distance of four hundred feet along the line between Green and Edwards leading toward Paris Station; thence in a line parallel with the first above mentioned line four hundred feet; thence in a line parallel with the second above mentioned line four hundred feet to the beginning corner, together with a right-of-way for ingress and egress along and next to the line between can have a Causada from the work of the line between the time of Green intercepts the line of Green up near the said Paris Station; that the term of this lease is five years, commencing the lat day of January, 1912, at the yearly rent of One Hundred Dollars (\$100.00) payable in advance.
