KNOW ALL MEN BY THESE PRESENTS THAT Melrose band Company a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville, South-Carolina, in the State of South Carolina, for and in consideration of the EMERCAT premises and of the sum of One Dollar dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee- - hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Dunean Mills, all the right, title and interest of Melrose Land Company in and to all that certain tract of land situate in County and State aforesaid, about two miles from the Greenville Court House, on the Greenville & Columbia Railroad, containing one hundred twenty-nine and twenty-seven one-hundredths (129.27) acres, more or less, and having the following lines, metes and bounds, to wit:

Sirrine, Engineer, on March 22nd, 1911, as the "beginning corner", being the corner of the tract herein described, end of lands of Mills Manufacturing Company and O.P.
