bargain, sell and release, unto the said P. N. Gallamore,
all that piece, parcel or lot of land in Greenville
Township, Greenville County, State of South Carolina, containing two miles north of the corporate

limits of the City of Greenville, known as lots nos. 1, 2, 3, and
4 of plot of land of D. C. Durham recorded in the
Book of Mesne Conveyance for said County in
Book No. 1, page 237 and having the following metes
and bounds: Beginning at a stake, the north corner
of Pine and Forsyth streets, and running thence
with line of street N. 43.71, two hundred ten feet to stake,
thence N. 25.25, one hundred forty-five feet to stake on
