in consideration of the sum of Nine hundred and Fifty 400 DOLLARS, to me in hand paid at and before the sealing of these presents by C. E. Craun

is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said C. E. Craun and his heirs and assigns forever. All that certain piece parcel or lot of land situated lying and being in the State of South Carolina and County and Township of Greenville about two miles west of Greenville Court House, S. C. near Monaghan Cotton Mills and being in the Town of New Hopes and being known and designated as Lot No. 3, on a plat thereof made by W. D. Neve, Esq., bearing date April 2nd, 1912, and recorded in Plat Book "C", at page 20, in the R. M. C. Office for said County and State, and having the following metes and bounds according to the above mentioned plat, to-wit: Beginning at a stake on Miller Street, 78 1/4 feet from the corner of Miller and Boatner Streets and running thence along Miller Street N. 9-30 E. 49 1/2 feet to a stake, thence N. 79-20 W. 107.5 feet to a stake, thence S. 79-20 W. 49.2 feet to a stake, corner of Lot No. 2, thence along line of lot No. 2, S. 79-20 E. 107.5 feet to the beginning corner, and being the same plot of land conveyed to me by W.
