This indenture made and entered into on this the 13th day of Nov. A.D. 1913, between Mrs. Alice E.-Freeman (also known as Mrs. Alice E. Grubbs), Mrs. Lydia M. Schwartz, George W. Freeman, Mrs.-Alice Nuessner and Mrs. Bonnie Kirchner (also known as Mrs. Napoleon B. Kirchner), parties of the first part, and Henry T. Mills, party of the second part.

W-I-T-N-E-S-S-E-T-H-:

That the parties of the first part have agreed for the consideration hereinafter named, to sell and convey to the party of the second part all that certain lot, piece or parcel of land situate, lying and being in the State of South Carolina and County of Greenville, in the Second Ward of the City of Greenville, having the following metes and bounds, to-wit:

Beginning at a stake on the northwest corner of Coffee and Brown Streets and running thence northward along said Brown Street one hundred (100) feet to a steke on the corner of lot belonging to W.C. Gibson; thence along said Gibson line Westward and parallel with Coffee Street one hundred (100) feet to a stake on the corner of Lot belonging to the wife and children of William H. Cauble, deceased; thence along the Cauble line southward and parallel with Brown Street one hundred (100) feet to a stake on the north side of Coffee Street; thence eastward along said Coffee Street one hundred (100) feet to the beginning corner; this being the same lot of land conveyed by Henry A.
