It is Mutually agreed by and between both of said parties that in the event one month's rent shall be in arrear and unpaid for a period of fifteen (15) days, the said party of the first part shall have the right to re-enter and forthwith re-possess the said above described premises. It is also mutually agreed that the said party of the second part shall not have the right to sublet or re-enter the above described premises without the written consent of the party of the first part. Witnesseth:

That whereas the said William Simes and Martha Louise Simes have separated and said Martha-Louise Simes has sued said William Simes for alimony and obtained an antiplicity interlocktory order for alimony of fifteen dollars per month, and one hundred dollars atto meys fee and suit money, and that whereas the said WIlliam Simes and Martha Louise Simes have agreed to live separately, and said William Simes has agreed to pay said Martha Louise Simes one thousand dollars in lieu of all claim of said Martha Louise Simes now accrued or hereafter accruing to her for alimony or support from said William Simes and also in settlement of said suit money and also in bar, lieu and settlement of all claim of dower which the said Martha Louise Simes has or may hereafter have inchoate or accrued in any land or lands owned by the said William Simes and in any land or lands which he may hereafter acquire, Now therefore in consideration of the payment of said amount of one thousand dollars to said Martha Louise Simes or her atto meys in said suit by said William Simes the said Martha Louise Simes hardhay hereby agrees to live separately and apart from the said William Simes, and make no further claim against him for alimony or support. and hereby releases him from all further obligation to her of any kind as a husband or in any way accruing from their marriage and she also renounces and releases in consideration thereof all dower mights in any land or lands of said William Simes accruing to her by reason of said marriage including all claim of dower inchoate or hereafter accruing in any land or lands now or hereafter owned by the said William Simes, and hereby covenants with said William Simes and binds herself not to claim dower of by reason of said marriage in any land or lands now or hereafter owned by said William Simes, and she hereby further agrees and binds herself to renounce her dower in the form pen prescribed by law on all mortgages which have been executed and delivered by said William Simes on any and all lands now owned by him; and to hereafter renounce her dower in such lands on all mortgages and deeds hereafter executed and delivered by him on any land or lands which he now ownes or may hereafter acquire.

And the said William Simes in consideration of the agreements and covenants of the said Martha-Louise Simes hereinbefore recited hereby releases said Martha Louise Simes from all obligations which she owes or may owe him as a wife, and agrees to live separate and apart from her; and he further agrees to pay the costs of said suit as taxed by the Clerk of Court.
