KNOW ALL MEN BY THESE PRESENTS, That I Gertrude I. Stober of Greenville

in the State aforesaid in consideration of the sum of Four hundred and fifty DOLLARS, to me in hand paid at and before the sealing of these presents by

Bruner McGee Co. a corporation of Greenville, S.C. (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Bruner McGee Co. All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, near the corporate limits of the City of Greenville, about two miles from Greenville Court House, beginning at an iron pin, on the east side of Dudley St., fifty-seven feet from the corner of Birch and Martin Streets, and thence with Dudley Street, in a southerly direction sixty six feet to corner of lot No. 213, thence with line of No. 213, in an easterly direction ninety-nine feet to a stake corner of lot conveyed by E. C. W. R. Kelly to W. R. Kelly, thence along said lot in a westerly direction sixty six feet to corner in lot conveyed to me by W. R. Kelly, thence with line of said lot in a westerly direction ninety-nine feet, more or less, to the beginning corner being a portion of lot #212 as shown on a plat made by W. V. Hudson, of the McGee land, and recorded in G.M.C. for said county in Plat Book B. at page 299, and being the same lot conveyed to me by E. C. & W. R.
