is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

J. D. Woods, his heirs and assigns, all that tract lot of land situated on Northwest side of Green Avenue, in the City and County of Greenville South Carolina, known as lot No. Ten on the map of the Peter Nelson, land as made by W. A. Adams, October 5th, 1909 and beginning at the corner of lot No. 9, on said Avenue fifty-six feet and ten inches from the intersection of said Avenue and a forty foot street, and runs thence N. 27 E. along said Avenue fifty six feet and ten inches to corner of lot No. eleven; thence along the line of lot No. eleven, one hundred and thirty six feet, and six inches to the line of lot No. eight; along the line of lot No. Eight; thence along line of No. Eight in a Southwestern direction, fifty two feet and to the corner of lot No. Nine; thence along the line of lot No. Nine, one hundred and thirty six feet and six inches to the beginning corner.
