KNOW ALL MEN BY THESE PRESENTS, That Mr. J. C. Peace and H. J. Alford doing business under the name of Bargain Real Estate Company, in the State aforesaid in consideration of the sum of Ten Dollars and other valuable considerations, DOLLARS, to us in hand paid at and before the sealing of these presents by Jim Williams,

(the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Jim Williams: All those certain pieces, parcels, or lots of land situate, lying and being on Markley Street in Ward Five of the City of Greenville, County of Greenville, and state of South Carolina, and being known as lots Nos. 26-28 and 27 according to a plat made by P. D. Butler for J. C. Peace Jan. 20th, 1914, and recorded in the R. M. L. office for Greenville Co. in Plat Book "D" Page 31 May 30th, 1914 and having the following courses and distances to wit:—Beginning at a pin on Markley Street fifty six (56) feet from the joint corners of a 16-foot alley and Markley Street being the joint corners of lots Nos. 24 and 26 and running thence with Markley Street Twenty six (76) feet into an alley thence up said alley in a Westerly direction One hundred two (102) feet to a pin in alley thence to and along the line of lots Nos. 27 and 28 in a Southerly direction seventy six (76) feet to a pin at the joint corners of lots Nos. 21-22-27 and 28 thence in an Easterly direction one hundred two (102) feet to the beginning point on Markley Street, including besides lots Nos. 26-28 and 27 five (5) feet of a 20-foot alley.
