C. R. M. Jankin (the receipt whereof is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

C. R. M. Jankin, all that lot or tract or parcel of land in Butler Township, State and County aforesaid, beginning at an iron pin on the Old Spartanburg Road, at the corner of Dr. J. C. West, and running thence N. 23 1/2 W. 18.35 Chaine to a stone; thence S. 75 W. 2.13 Chaine to a stone; thence N. 23 1/2 W. 3.65 Chaine to a stake; thence S. 64 W. 7.20 Chaine to a stake in the center of a right of way fifteen feet wide; thence along the center of said right of way S. 26 E. 15.75 Chaine to a stone in center of the Old Spartanburg Road; thence along said road N. 82 E. 3.15 Chaine to bend in road; thence S. 84 3/4 E. 2.36 Chaine to bend in road; thence S. 61 1/2 E. 5.33 Chaine to the beginning corner, containing fifteen acres (15), more or less, and having such rotes and boundaries as appear by reference to survey made by W.
