

A. R. Fowler DEED TO W. H. Buchanan

KNOW ALL MEN BY THESE PRESENTS, That I, A. R. Fowler of the County and State aforesaid in consideration of the sum of Thirty-one hundred and thirty DOLLARS in hand paid at and before the sealing of these presents by W. H. Buchanan of the same county and state

by acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said W. H. Buchanan: - That certain piece, parcel and tract of land situated and lying in the County and State aforesaid containing twenty acres, more or less, about fifteen and one-half miles South of Greenville City on the old Greenville and Laurens road, about half way between the Towns of Simpsonville and Fountain Spr., adjoining lands of myself, Maggie S. Fowler, R. Bryson, W. A. Fowler and others, beginning in the center of the Laurens road and running thence N. 28 1/2 E. 12.84 to a stone, thence N. 40 1/2 E. 5.00 to a stone, thence N. 51 1/4 E. 8.50 to a stone, thence S. 24 1/4 W. 2.10 to a stone, thence S. 56 E. 7.50 to a stone, thence S. 27 1/4 W. 14.80 to a stone, thence N. 82 W. 2.64 to a stone, thence S. 77 W. 4.88 to a stone, thence S. 87 W. 3.60 to a stone, thence S. 34 3/4 W. 2.95 to a stone, thence N. 47 W. 2.80 to the beginning corner as represented by a plat made by J.
