KNOW ALL MEN BY THESE PRESENTS, That I, Andy W. Seaborn of the City and County of Greenville in the State aforesaid

in consideration of the sum of Two hundred and twenty-five DOLLARS and other good and valuable considerations to me in hand paid at and before the sealing of these presents by Ava J. Fortner

(the receipt whereof is here-by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Ava J. Fortner, and her heirs and assigns forever, All that certain parcel or lot of land situate,

lying and being in the State of South Carolina and in the City and County of Greenville, in the North Ward of said City and near Wilkins and Sullivan Streets, having the following

measures, courses and distances, according to a survey thereof, made by Hewitt Butler, to-wit: Beginning at an iron pin and running thence S. 94 W. 178 feet to an iron pin; thence S. 76 E. 61 feet to an iron pin on a 10 foot alley, (said alley running from Wilkins Street to Sullivan Street) thence along said 10 foot alley N. 8 E. 188 feet to an iron pin; thence N. 88 W. 16 feet to the beginning corner, this being a part of land conveyed to me, the said Andy W. Seaborn by The Workmens Carriage and Loan Company by a deed bearing date 23rd, day of May 1903, and recorded in the R. M. C. Office for Greenville County in the State of South Carolina in Book "J. G. G." at page 593.

H. P. Haley, and his heirs and assigns, all that certain piece or parcel of land situate, lying and being in the State of South Carolina and County and Township of Greenville, about one and one half (1 1/2) miles north of the County Court House, and near the (Grisson) Spring Company Mill, having the following
