KNOW ALL MEN BY THESE PRESENTS, That J. W. Trammell in the State aforesaid in consideration of the sum of thirty-five hundred DOLLARS to me in hand paid at and before the sealing of these presents by Joe P. Pool and H. C. Pool

(the receipt whereof is here- by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said Joe P. Pool and H. C. Pool all that piece parcel or lot of land situate being and being on the north side of Earle Street in the City of Greenville in the State and County aforesaid. Between Townes and Willow Sts. Union, his heirs and assigns forever, all that piece parcel or lot of land situate, being and being in the City of Greenville, County and State aforesaid; Beginning at a stake on the west side of Fall St. thence N. 71 W. 120 feet to a stake on an alley; thence with said alley S. 19 W. 64 feet to a stake on an alley; thence S. 70 E. 120 feet to a stake on Fall St. thence along Fall St. to the beginning corner, being the same lot of land conveyed to me by J.
