Gluron, his heirs and assigns, all those certain lots of land situate lying, and being in the County of Greenville, State of South Carolina, in the City of Greenville, near Furman University, being lots nos. six, nineteen, five, one, two, and three, designated on a plat of land purchased by me from A. Moore and by him from Mrs. Thurston, said plat having been made by Wm. A. Hudson, on the twenty-first day of March, 1908, said plat being recorded in the R. M. C. Office for Greenville County in Plat Book A, at page 225. This being the same tract of land mortgaged by me to C. F. Hill, Esq., on the second day of February, A.
