BY THE SECRETARY OF STATE

WHEREAS, Clinton J. Morgan and C.F. Haynsworth, of Greenville, S.C.

did on the 23rd, day of July, 1917, file with the Secretary of State a written Declaration, signed by themselves, setting forth:

First: The names and residences of the said petitioners to be as above given.

Second: The name of the proposed corporation be that of Sevier Transfer Co.,

Third: The principal place of business of the corporation will be Greenville, S.C.

Fourth: The general purpose of the corporation, and the nature of business it proposes to do.

Is to own and operate automobiles and automobile trucks for hire, to maintain and operate garages, storehouses, storerooms and repair shops to store and repair automobiles, to buy and sell Automobiles, automobile parts and supplies and other merchandise, to buy, sell and lease real estate.

Clinton J. Morgan, J.H. Morgan, Jr., J.F. Richardson, Jr., W.D. Parrish and C.F. Haynsworth, That subsequently there was elected as President, Clinton J. Morgan, as Vice President - - - - -; as Secretary, - Jas. H. Morgan, Jr.; as Treasurer, Jas. H. Morgan, Jr.

Fifth: The amount of the capital stock to be Eight Thousand (\$8000.) Dollars

and the number of shares into which the same is to be divided to be one hundred and sixty (160)

Sixth: The capital stock to be payable as set forth in the Declaration and Petition. Fifty (\$50.00) dollars each.

AND WHEREAS, on the 23rd, day of July, A. D. 1917, the date above named, petitioners were commissioned by me a Board of Corporators;

AND WHEREAS, the said Board of Corporators, on the 27th, day of July, 1917, did file with the Secretary of State their return in writing, over their signatures, certifying, among other things, that pursuant to publish notice as required in the commission of the said Corporators, the books of subscription to the capital stock of the aforesaid Company were opened and that thereupon a meeting of stockholders was called, and the aforesaid Company duly organized by the election of a Board of Directors, and other necessary officers. That, furthermore, they have complied with all the requirements of the Code of Laws of the State of South Carolina of 1912, and all Acts or parts of Acts amendatory thereto;

NOW, THEREFORE, I, W. Banks Dove, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said company has been fully organized according to the laws of South Carolina, under the name and for the purpose indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Meane Conveyance in each county where such Corporation shall have a business office.
