WHEREAS, By an act of the General Assembly of the State of South Carolina, entitled" An Act in Relation to Ferfeited Lands, Delinquent Lands and Collection of Taxes", and Acts Amendatory thereof, it is provided that immediately upon the expiration of the time allowed by law for the payment of taxes in any year the County Treasurer of each County shall issue, in the name of the State, a warrant or execution against each defaulting taxpayer in his County, directed to the Sheriff or his lawful deputy, requiring and commanding him to levy the same by distress and sale of so much of the taxpayor's estate, real or personal, or both, as may be sufficient to satisfy the taxes-State, School, County and Special of such defaulters; and further, that under and by virtue of such warrant or execution the Sheriff shall take exclusive possession of so much of the defaulting taxpayer's estate; real er personal, er both, as may be necessary to raise a sum of money named therein and the charges theren, and after due advertisement, sell the same before the Court House door of the County on a regular Salesday and within the usual hours for public sales, for cash, make titles therfor to the purchaser, complying with the terms of sale, and put the purchaser in possession of the property And Whereas, There appears on the Tax Duplicate of Greenville County, County for the fiscal year commencing November 1st,1911, and ending Nov.1,1914, certain real estate consisting of one lot of land in Greenville County, State aforesaid, known as Let No.3 on Plat of the Richland Land Co., recorded in Plat Book "A", page 315, for a more complete description of which reference thereto is hereby made, See also Deed Book "PPP" page 273, records R.M.C.Office said County and State, assessed in the name of S.S. Cartee, and valued at Ten Dollars, the taxes, penalties and assessments thereon amounting for five years to Feurteen & 75/100, Dollars; and

TO HAVE AND TO HOLD, All and singular, the premises hereby granted, with the appurtenances, unto the said J.N.King, Agent for Mrs. Evie Rector, her heirs and assigns forever, according to the form, force and effect of the laws and the usages of the State of South Carolina, in such cases made and provided,
