AGREEMENT.

This agreement made and entered into by nad between J. JJMcSwain, Lessor and L.V. Jordan and A.J. Jordan, lesses, witnesseth:

- 1. That the said lessor does lease unto lessees that farm in Dunklin Township at the corss' of the public road known as the Greenville and Pelzer Road, and whereon the lesses now live, containing forty-eight acres, more or less, for the year 1916 in consideration of the rental of five bales of lint cotton weighing five hundred pounds each, to be paid out of the first cotton gathered on said place; the said lessees agree to plant at least twenty-acres in cotton and to manure and cultivate same properly.
- 2. This lease is to be extended and renewed from year to year if the lessees pay the rent in full promptly, taking care of the place properly; making all necessary repairs on the residence and outbuildings.
- 3. Lessees may reddem said land upon terms and conditions to be stipulated and agreed upon the parties at the time the lessees seek to redeem, but in no event shall the right of redemption exist without full performance of all conditions of this lease.
- 4. If the lessees fail to properly and fully comply with the stipulations of this lease, they shall then be as a tenant holding over after the expiration of their term.

Dobson, his heirs and assigns forever, And I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises above mentioned unto the said R.D. Dobson, his heirs and assigns against me and my heirs and any person a lawfully claiming and by or through myself or my heirs or assigns.
