Stall and Bessie B .-Stall all my right, title, interest, estate, claim and demand whatsoever, both at law and in equity, in and to that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina and County of Greenville, in the Second Ward of the City of Greenville, known and designated as lot No.1 on a plat made by Will D. Neves for D.B. Traxler, agent, dated April 1912, and having, according to such plat, the following metes and bounds, to-wit: Beginning at a stake on the east side of Rowley Street one hundred and seventy-two (172) feet, more or less, from Park Avenue, and running thence S.76° 30' E. one hundred and fifty-seven (157) feet to a stake; thence N. 30° 30' E. fifty-two (52) feet to a stake on the corner of lot No. 2; thence along line of last mentioned lot N. 76° 30' W. one hundred and sixty-six and eight -tenths (166.8) feet to a stake on Rowley Street; thence with said Rowley Street S. 20° 10° W. fifty (50) feet to the beginning corner.
