In consideration of the sum of One Dollar to it in hand paid, the receipt whereof is hereby acknowledged, Realty Corporation does hereby agree to lease to A.L. Mills, as President of the Greenville Chamber of Commerce, his successors and assigns, twenty-five acres, more or less, of land by it owned in Chick Springs Township, Greenville County, South Carolina, near Paris Station, bounded by lands of J.Lee Green on the north, road leading to Paris Mountain on the West, and on the South by a line parallel with and 200 feet distant from the center line of the main line track of the Piedmont and Northern Railway Company, for use of the United States, as a camp for training troops or other military purposes, for the term of one year from January 1st, 1918, at the annual rental of Seven Dollars per acre, with the yearly option and privilege of four consecutive annual renewals. The Government may remove all houses, pipes, pole lines and all fixtures of any kind whatsoever, which it places on the premises.

This option shall be good until December 31st, 1917. If exercised in that period Realty Corporation will give possession of the land in 10 days and rentals shall be paid it on a pro-rate basis for the fraction of the present year.

Any damage to crops now or hereafter planted on said land shall be paid for at a price agreed upon and if such cannot be arrived at, then the damage shall be determined by arbitrators, one to be chosen by Realty Corporation, one by the holder of this Option and the two so appointed will select a third. The decision of any two of the three arbitrators to be final. Any damage to buildings shall be settled for in the same manner.
