A right of way, 15 feet in width ( that is to say,  $7-\frac{1}{2}$  feet on either side of the center line of the industrial spur track of the Railway Company, hereinafter described), over and upon the land of the party of the first part, situate, lying and being at Fallis, in the County of Greenville and State of South Carolina, for an industrial spur track of the Railway Company, which springs from its passing track lying next west of and parallel with the main track of the Railway Company running between Charlotte and Atlanta, at a point thereon 1364.3 feet south of Milepost 489, and extends thence in a Northwesterly direction, for a distance of 411 feet, more or less, of which 343 feet, more or less, is located upon the present right of way of the Railway Company for its said Main Track, and 68 feet, more or less, upon the said land of the party of the first part.
