Batson on the east, Gus Bridwell on the south and A. Bradley on the west, and to construct and maintain in, upon and through said premises, in a proper manner, with poles, towers, wires and other necessary apparatus and appliances, lines for the purpose of transmitting power by electricity and telephone service, together with the right at all times, to enter upon said premises for the purpose of inspecting said lines and making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines, all trees and other like obstructions that may in anyway, endanger the proper operation of the same.

The payment above specified is accepted in full settlement of all claims for said easement. Any damages to crops planted, shall be paid for at a price to be agreed upon, and if such can not be arrived at mutually, the damage shall be determined by arbitrators, one to be chosen by me, one by the holder of this grant, and the two so appointed to select a third.

The decision of any two of the three arbitrators shall be final. The above amount is based on ten poles, and if more than ten poles are placed on the above premises I am to receive three dollars for each additional pole. All wood cut must be cut & split & neatly corded on the land-pine to be cut in 4 foot lengths & oak cut in 8 foot lengths.

Bull of said County and State in consideration of the premises, and of the sum of Eighteen & 00/100 Dollars to - - in hand paid by the City of Greenville South Carolina, the receipt whereof is hereby acknowledged, do hereby grant unto the said City of Greenville, its successors and assigns, the right, privilege and easement to go in and upon that tract of land, situated in said County and State, bounded by lands of J.H. Betson on the north, Mrs. H.E. McCarter on the East, Mrs. Phoebe Jones on the South and J.H. Betson on the west and to construct and maintain in, upon, and through said premises, in a proper menner, with poles, towers, wires and other necessary apparatus and appliances, lines for the purpose of transmitting power by electricity and telephone service, together with the right at all times to enter upon said premises for the purpose of inspecting said lines, and making necessary repairs and alterations thereon; together with the right to cut away and keep clear of said lines, all trees and other like obstructions that may in anyway, endanger the proper operation of the same.
