Beattie had during his lifetime, and which we may have as executors of his will, in and to all that certain lot, piece, or parcel of land situate, lying and being in the State of South Carolina and County of Greenville, in the First Ward of the City of Greenville, known and designated as lot No. 6 on a plat of J.E. Beattie's Buncombe Street property, copied by J.E. Sirrine from a survey made by Joe T. Lawrence on April 15, 1909 and having, according to said plat the following metes and bounds, to-wit:

Beginning at a stake on Whitner Street on the original corner of J.E.
