All those certain lots situate in the City of Greenville, County and State aforesaid known as lots 83, 99, 146, 150 and 151 of East Park, as shown on plat recorded in Plat Book A, page 383; being the same lots conveyed to me by T. F. Hunt, as Trustee, by deed recorded in Vol. 7, page 344. Subject however to a mortgage recorded Vol. 14, page 309. Also all those certain lots situate in the City of Greenville, County and State aforesaid known as lots 6, 7, 8, 38, 39, 47, 48, 182, 188 and 90 of East Park as shown on plat recorded Plat Book A, page 383; being the same lots conveyed to me by John Mah Boesemeyer by deed recorded Vol. 24 page 509, subject however to a mortgage recorded Vol. 29 page 243. Also all that certain tract of land situate on the Parc Mountain Road in the County and State aforesaid containing four acres, and being the same land conveyed to me by M. A. Smith by deed recorded Vol. 9, page 203, subject however to a mortgage recorded Vol. 49 page 197. Also all that certain lot of land situate in the City of Greenville, County and State aforesaid fronting 50 feet on Anderson Road and having a depth of 150 feet, being the same lot conveyed to me by Olive Van Patten by deed recorded Vol. 23 page 463; subject however to three mortgages recorded Vol. 600 page 179; Vol. 600 page 188 and Vol. 40 page 233, respectively. Also all those certain lots situate in the County and State aforesaid known as lots 5, 6, 7, 8, 9, 11, 12, 16, 17, 18, 19, 20, 23, 24, 28, 29, 30, 37, 38, 39, 40, 41, 42, 43, 44, 45, 46 and 47 of Sans Souci Drive as shown on plat recorded in Plat Book C page 29. It being the intention of this deed to convey all the property conveyed to me by two deeds, one from D. B. Trapler recorded Vol. 17 page 203, and the other from Alice d' Battle recorded Vol. 21 page 132, except such lots as have been conveyed by me subject however to a mortgage recorded Vol. 22 page 156. Also all that certain lot of land situate in the County and State aforesaid known as lot 25 of Richland Hill, and being the same lot conveyed to me by Eva J. Martinez by deed recorded Vol. 19 page 241, subject to a mortgage recorded Vol. 30 page 64. Also all that certain lot of land situate in the County and State aforesaid on the North side of Cedar Lane Road known as lot #5 on plat made by T. F. Rogers Beginning at a stake on said road 84 feet from the Northwest corner of said road and Monroe Street, thence up said road N. 39 W. 60 feet, thence N. 51 E. 154 feet, thence S. 34 E. 32 feet, thence S. 45 W. 70 feet, thence S. 57 E. 60 feet, thence S. 47 W. 90 feet to the beginning. Then going further of the land conveyed to me by T. F. Rogers by deed recorded Vol. 10 page 1264. Subject however to a mortgage recorded Vol. 15 page 239. Also all those certain lots of land in the County and State aforesaid known as lots No. 1 and 3 of the aforesaid plat made by T. F.
