Know all men by these presents that the Standard Warehouse Company for and in consideration of the sum of \$1,000.00 to it in hand paid at end before the sealing of these presents by Piedmont Bonded Warehouse & Compress Company (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Piedmont Bonded Warehouse & Compress Company the following described real estate, to-wit:

All that certain parcel, piece or lot of land with the improvements thereon, situate, lying and being near the western limits of the City of Greenville, in the State of South Carolina, containing Eight and one-tenth (8-1/10) acres, more or less, and being irregular in shape:

Beginning at an iron pin in the center of Farr's Bridge Road twelve and one-half (12-1/2) feet east of the center of railroad track to the Bleachery, and running thence N. 61 W. two hundred and eighty-seven feet one inch (287' 1") along the center of said Farr's bridge road to iron pin at the corner of Poe Street; thence turning and running along the center of said Poe Street N. 81° 25' W. one hundred and sixty one and one-half (161-1/2") feet to iron pin at corner of Poe Street and an alley; thence turning and running S. 15 W. five hundred and twenty feet (520') along said alley to iron pin; thence turning and running N. 89° 35' E. two hundred -
