in consideration of the sum of Thirty-one hundred fifty dollars (\$315.00) DOLLARS
to me in hand paid at and before the sealing of these presents by

H. M. Ridgway, of Greenville County -

(the receipt whereof is here-

by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said H. M. Ridgway, all those two (2) certain lots, pieces, parcels or tracts of land situated, lying and being in said State & County in Greenville Township on road leading from Augusta road to Spurting Shoals via Mr. R. C. Stephen's property, Shrynham place, lot piece per parcel No. 1 on which said dwelling is located, containing 20 acres more or less and having following precise and bound: Beginning on a Spanish oak 1/1X on road, thence 64 3/4 E. 10.61 chains to stone 1/1X, thence N. 93 1/2 W. 86. length to red oak 1/1X; thence 13 1/2 N. 144.32 chains to stone 1/1X, thence S. 65 1/2 E. 24.70 chains to stone 1/1X (new); thence S. 26 E. 145.8 chains to stone 1/1X; thence N. 36 3/4 E. 16.60 chains to beginning corner, bounded by lands of J. A. Shrynham, H. M. Ridgway and tract No. 2 known as Saucy's Shrynham place, tract hereafter known as No. 2. Being said J. A.
