W. P. Nesbitt DEED TO E. M. Anderson

THE STATE OF SOUTH CAROLINA, County of Greenville

NOW, KNOW ALL MEN BY THESE PRESENTS, That E. W. P. Nesbitt of the County of Greenville in the State aforesaid in consideration of the sum of Ten Dollars \$10.00 and other valuable consideration to me in hand paid at and before the sealing of these presents by E. M. Anderson

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said E. M. Anderson, his heirs and assigns forever, all that tract of land and parcels of land, situate, lying and being in the County and State aforesaid, in Fairways near waters of Reedy River and on the East side of Martins Creek, containing two hundred thirty seven and 3/4 (237 3/4) acres, more or less, and having the following meter and bounds, to wit: Beginning at a silver stake on the East bank of Martins Creek near old ford, and running thence N. 74 3/4 E. 58.50 to a stone on branch, R. A. Bach corner, on branch line; thence down the said Branch S. 7 1/2 W. 8.50 chains to stone, two double poplar witnesses; thence S. 7 1/2 E. 25.10 chains to a stone on hill; thence S. 2 1/3 W. 7.74 chains to a stone on branch, Nady and Babbs corner; thence with the meander line of said small branch to intersection with big branch; thence with meander line of said big branch to its intersection with Martins Creek; thence up Martins Creek to the beginning corner, adjoining lands of Nesbitt estate, Mrs. J. J. Hollen, John Bradley R. A. Nash, Clint Babbs and others. The same being a portion of 436.26 acres of land lying in Greenville and Laurens Counties, conveyed to E. W. Nesbitt by George W.
