(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said H. O. Grace all that piece, parcel or land in the said Greenville Township, County of Greenville, State of South Carolina, in Ward One of the City of Greenville and having the following metes and bounds: Beginning at an iron post at the corner of Buckner (now Edmonson's Parker) Street and an alley twelve feet wide, and running thence with said alley S. 71° E. one hundred and thirty-seven feet to a iron post at corner of Mary Jane Brown's lot, thence with line of said Mary Jane Brown's lot N. 21° E. fifty-six feet to a iron post at corner of Bertha Boogers lot, thence with line of Bertha Boogers lot S. 71° W. one hundred feet to an iron post on Buckner Street; thence with Buckner Street S. 48°-30' W. seventy-seven feet to the beginning corner, known as lot No. 21 now a plot made by J.
