NOW, KNOW ALL MEN BY THESE PRESENTS, That I Francis R Pitman, of the town of Spartanburg, County of Spartanburg, in the State aforesaid in consideration of the sum of One Hundred Eighty and two DOLLARS, to me in hand paid at and before the sealing of these presents by Mrs Mannie Ethel Lee, of the town of Spartanburg, County of Spartanburg, State of South Carolina, (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said Mannie Ethel Lee; all that certain piece or parcel of land lying and situate in Clayton, Fountain Inn, Greenville County of Greenville, State of South Carolina; Beginning at a stone on D. M. Lockhart's line; thence running North 30° N. 20.77 chs. to a stone, corner of D. M. Lockhart and Francis R. Pitman, and Mrs Mannie Ethel Lee. Thence with the said Mannie Lee's line S. 28° E. 4.20 chs. to a stone, thence with said line S. 43° N. 2.50 chs. to a stone, corner of H. H.
