NOW KNOW ALL MEN BY THESE PRESENTS, That W. M. Mattison of the City and County of Anderson in the State aforesaid in consideration of the sum of Fifty-two Hundred (\$5200.00) DOLLARS, to me in hand paid at and before the sealing of these presents by H. Frank Hipp of the City of Greenville in the State aforesaid.

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said H. Frank Hipp his heirs and assigns, all that certain piece, parcel or lot of land situate, being and being in the City of Greenville, County of Greenville, State aforesaid, being known as lot No. 17 according to survey made by W. A. Adams January 7, 1916, and being the same lot conveyed to me by S. M. Sigon by deed dated September 22nd, 1913, recorded in the Clerk's Office for Greenville County in Book 19, page 563, to which said instrument is invited for a more particular description of the lot by courses and distances.
