NOW, KNOW ALL MEN BY THESE PRESENTS, That I, J. F. Donald, in the State aforesaid in consideration of the sum of Fifty one hundred DOLLARS, to me in hand paid at and before the sealing of these presents by B. H. Walker

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said B. H. Walker his heirs and assigns, all of two certain parcels or tracts of land situate lying and being in the State and County above named and above Township, and described as follows: Tract No. One Bounded on the West by lands of J. B. Bennett on the South by land of R. D. Whitt deceased, on the East by land of J. F. Roe and the North by land of J. J. Harrison known as the old Richardson place, and containing twenty one acres more or less, and being the same tract of land conveyed to J. F. Donald by C. Dunham Master Greenville County, dated Dec. 31, 1915 and recorded in R. M. C. Office for Greenville Co. Book 5 page 683.
