(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release unto the said C. A. Edwards

all that piece parcel or lot of land lying and situate in the town of Fountain Inn, County of Greenville State aforesaid containing three fourches of land or more or less, Beginning on corner of John R. Davis lot formerly owned by Marshal D. C.
