 (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

*W. J. G. Smith* and *W. L. J. Smith* all that piece, parcel or lot of land situate in the County and State aforesaid, and being the following corner and boundary, beginning at a stone set in the *Woodward Street* corner aforesaid, thence along *Woodward Street* 70 feet more or less, then turning to the right angle of *Woodward Street*, thence along *Woodward Street* 209 feet, thence turning to the left angle of *Woodward Street*, thence along *Woodward Street* 209 feet to the beginning corner. This lot is bounded on the south side of *Woodward Street*.
