S. V. Brockman DEED TO Andy Balcombe and Pratt Balcombe  
THE STATE OF SOUTH CAROLINA,  
COUNTY OF Greenville

NOW, KNOW ALL MEN BY THESE PRESENTS, That I, S. V. Brockman of the County of Spartanburg, in the State aforesaid, in consideration of the sum of Three thousand and five hundred and fifty DOLLARS, to me in hand paid at and before the sealing of these presents by Andy Balcombe and Pratt Balcombe of the County of Greenville in the State aforesaid (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Andy Balcombe and Pratt Balcombe all that certain tract or parcel of land lying, being and situated in the County of Greenville, in the State of South Carolina, containing eighty three (83) acres more or less, bounded by lands of M. P. Nash, Rufus Rabb, Wm Taylor, Rabb Thompson and Thos. Cooper being the same conveyed to me by E. Brown Master, by deed recorded in Vol 40 page 173 in R. M. C. office for Greenville County, S. C. of the above stated purchase price only eight hundred dollars has been paid, the balance of \$2,255.80 being evidenced by six notes of grantees each for \$375.90 of date January 9th, 1918 (this deed having been delivered on last named date) secured by a mortgage on the real estate above described (which said mortgage bears same date as notes above referred to and will be recorded in R. M. C. office for Greenville County, S. C.)

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Andy Balcombe and Pratt Balcombe, their heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Andy Balcombe and Pratt Balcombe, their heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
