Crisickbank, my tract piece, parcel or lot of land, situate, lying and being on Webster Street, (Formerly Hudson Street) in the 4th Ward of the City of Greenville, State and County aforesaid, Beginning at an iron rail on Webster Street, (Formerly Hudson Street), said rail, running thence N. 03-37' W. 115 feet to a stake on Webster Street, thence S. 24-1/2 W. 105 feet to a corner, thence S. 06-1/2 E. 145 feet to Marchbanks' line; thence N. 23-1/2 E. 105 feet to the beginning corner, and so lying, the same lot of land conveyed to me by W.
