(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Elizabeth M. Mayo, all that certain piece, parcel or lot of land on the Foster side of Stwood Street, in the City of Greenville, having the following streets and bounds, to wit:

Begins at corner of the present Elizabeth M. Mayo's, lot and runs along the side with Stwood Street, L. 40-5 & 10 ft to corner lying between Foster Street 50 feet & 10 feet from front line in Foster Street being A. 10-12 C. 11. 6 feet, then east to the rear line of Elizabeth M.
