(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said L. Augustus Green, the following described real estate:-

All that certain parcel and tract of land situate, lying and being in South Carolina, Greenville County, on the south side of a road leading from McStellie's Mill almost due west, in direction of Washington Church, and bearing the following metes and bounds to wit: Beginning at a stake on the south side of the said road and running thence S. 4 7/8 N. 19.80 chains to a stake on the north side of the said road, thence down the said river to a Birch on the north bank of said river, 3 1/4; thence N. 4 7/8 E. 12.10 chains to a stake on the south side of said road, thence nearly W. with said road to the beginning corner, containing 13 3/4 acres, more or less, and being the same tract of land conveyed to the said Frank Forest by Meek M.
