(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said H. D. Howard and his heirs and assigns, all that

certain piece, parcel or lot of land, situated, lying and being in the State of South Carolina and County of Greenville, in the Parish of Moultrie, on the west side of North West Creek and North West Creek, having the following description to-wit:

beginning at a certain abstract 34, and running thence nearly West to a cypress tree 34; thence nearly West to a stake at the Spring, at a point of intersection, thence nearly East with Joshua's line to a Hickory 34; thence nearly South East, course to a Pine 34, a part part of Blaney Rock; thence nearly S. E. to a red beginning corner, and containing twenty-five (25) acres, more or less, and bounded by lands of J. H. Hickey, H. D. Howard and others.
