NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Lawrence C. White of Greenville County and the State aforesaid in consideration of the sum of Ten Thousand Dollars, to \$10,000 in hand paid at and before the sealing of these presents by J. G. Tucker of Greenville County

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. G. Tucker

all that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina about one mile from Greerette Mill, near the road to Manfield, being a part of a tract conveyed to J. D. White by G. D. Louisville, adjoining lands of J. D. White & C. White and Rhode D. Foster, being bounded as follows: Beginning on a rock, 8<sup>1</sup>/<sub>2</sub>, thence S. 84<sup>1</sup>/<sub>2</sub> W. 3.98 to a rock, thence S. 21<sup>1</sup>/<sub>2</sub> W. 14.83 to a rock, 340 m., thence S. 22<sup>1</sup>/<sub>2</sub> E. 7.00 to a rock, 340 m., thence S. 47<sup>3</sup>/<sub>4</sub> E. 0.63 to a stake, thence N. 16<sup>3</sup>/<sub>4</sub> E. 26.94 to the beginning together with a right of way along the line between the lands of J.
