Deed to Andy Harris

KNOW ALL MEN BY THESE PRESENTS, That Joe A. McCallough, C. C. Good, and J. D. Smith, of the County of Greenville

in the State aforesaid, in consideration of the sum of Twenty five (\$25.00) DOLLARS, to us in hand paid at and before the sealing of these presents by Andy Harris

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Andy Harris, his heirs and assigns: - All that certain piece, parcel and lot of land, situate lying and being in Ward four of the City and County of Greenville and State of South Carolina, on the South side of an Alley running parallel with McBee Avenue, in the rear of the Colored Baptist Church, and having the following meter and bounds, to-wit: Beginning at an iron pipe on said Alley, and running thence S. 18 W. 86 2/3 feet to an iron pipe, thence N. 73-28 W. 31.8 feet to an iron pipe; thence N. 38-04 E. 92.6 feet to the beginning corner, and being part of the same land heretofore conveyed by Andy Harris to C. C. Good, Joe A. McCallough & J. D. Smith.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Andy Harris, his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Andy Harris, his heirs and assigns, against us and him heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
