(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

J. H. Glenn, all that certain piece, parcel or tract of land, situate, lying and being in Bates Township, County and State aforesaid, containing ten and ninety three one hundred fiftieths ($10 \frac{93}{100}$) acres more or less, and bounded by lands of J. M. Ferguson, W. E. Hart and J. H. Glenn and having the following meter and bounds to wit: Beginning at a poplar, and running thence S. 38 E. 10.32 chs. to a stone, thence N. 68 E. 11.40 chs. to a stone in the road, thence N. 38 W. 9.50 chs. to a stake in the road, thence S. 72 W. 11.40 chs. to the beginning corner and being the same tract of land conveyed to me by D. Frank Ferguson, by Deed, bearing date of November 6th, 1915 and recorded in R. M. C. Office for Greenville County S. C. in Vol. 38 page 168.
