In the State aforesaid,
in consideration of the sum of *Ten Dollars, (\$10.00)* and other valuable considerations DOLLARS,
to *H. Abercrombie* in hand paid
at and before the sealing of these presents by *H. Abercrombie*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *H. Abercrombie*, his Heirs and Assigns; to-wit

that certain pieces, parcels or lot of land situated, lying and being on the East side of David's Street, in the City of *Greenville*, County and State aforesaid, and being designated as Lot #3 on plat recorded in R. S. M. & C. office for *Greenville County* in Plat Book #1, pages 108, and having the following corner and dimensions, to-wit: Beginning at an iron pin on David Street, corner of Lot #1, and running thence with David Street, S. 23-1/2° E. 52 feet to corner of lot #3; thence with the line of lot #3, N. 66-3/4° E. 116-2/3 feet to an iron pin on line of lot #5; thence with said line of lot #5, N. 23-1/2° E. 12 feet to an iron pin, corner of lot #4; thence with line of lot #4, S. 66-3/4° E. 46-2/3 feet to an iron pin, corner of lot #4; thence with line of lot #4, N. 23-1/2° E. 40 feet to corner of lot #1; thence with the line of lot #1, S. 66-3/4° E. 70 feet to the beginning corner, and being one of the lots of land conveyed to me by *S.
