unto the said Mattie A. Estes and her bodily heirs,

All that piece parcel and tract of land situated
lying and being in State and County aforesaid
and in Dunklin township on branches of Little
Horse Creek waters of Reedy River, containing
forty-six acres more or less, bounded by lands
belonging to Jas. A. Scott, D. L. Q. West,
Victor H. Daynham and W. M. Woods beginning
at a stone #111 on aforesaid C. D. West's line
